## SAVE Focus 2003 published

A new edition of the SAVE Focus, published every second year, reports on the development of cross-borderly endangered livestock breeds, their problems, the need for action, co-ordination efforts and their success. SAVE lists the most recent stock numbers for Huzul horses, Mangalitsa porcs, Girgentana goats, Pusteria and Red Cattle, and five sheep breeds, subdivided into the individual breeding countries. The breeds are described and addresses of breeding responsables are given. Each breed is portrayed with a picture.



For the first time, a sheep breed could be released from monitoring. The "Brown Mountain", present in four countries of the Alpine region under five different names, has overcome the status of being endangered. In Germany (Braunes Bergschaf) and Switzerland (red Engadine or Besch da Pader), population numbers have since long exceeded the thousand mark note, in Austria (Paterschaf, Braunes Bergschaf) and Italy (Val d'Ultimo, Ultnerschaf), stocks will soon

reach this level. According to FAO criteria, the entire stock is still considered to be vulnerable and needs further governmental support. The danger of extinction has, however, become very small. Breeders co-operate across national borders and the future seems safe.

## Conclusion of the seventh meeting of the Conference of the Parties

The Conference of the Parties (COP) is the highest decision-making body of the Convention on Biological Diversity (CBD). Meetings are held every two years.



20 February 2004: At the conclusion of the seventh meeting of the Conference of the Parties (COP-7) in Kuala Lumpur, Malaysia, the 187 member states, with the European Community, agreed on a more quantitative approach to reducing the rate of biodiversity loss by the end of the decade. Another important accomplishment of the meeting, which was attended by over 2,000 participants, including 80 ministers, is the launch of new talks on the crafting of an international regime on access to and equitable sharing of the benefits arising out of the utilization of genetic resources.





## EU Commission launches 1467 replacement program

Good things come to those who wait: The European Commission has accepted the draft of a Council Regulation for a second Common Program for "Conservation, characterisation, collection and utilisation of agricultural genetic resources". This program is to replace Council Regulation 1467/94, which already expired in December 1999. For a first period from 2004 to 2006, 10 million Euros are earmarked within the EU budget. At present, the draft from 22<sup>nd</sup> of Dec. 2003 has been submitted to the Council for passing. Presumably, the new Council Regulation will become final in spring 2004. Upon completion of the working program, the first call for project submission may be expected in autumn 2004.

The means of the new EU-program, however, are limited. But the possibilities for NGOs and for *in-situ* /on-farm conservation projects have improved considerably compared to the old regulation 1467/94. We will keep you up-to-date on the future development.

## EU Commission battles against animal diseases

The European Commission is going to provide financing of 147 million Euro to battle against BSE and other animal diseases. 92.64 million are provided for the observation and combat against scrapie and BSE, in acceding countries too. A further 54.29 million go to the combat against brucellosis, rabies and for animal disease precaution. All these diseases – with their enormous influence on both human and animal health – result in considerable losses in animal production and pose a barrier for both in-house EU trade and world trade.

With regard to BSE, the commission has created an Internet portal, which is continually updated. In a chronological overview, all EU-decisions and EU-regulations concerning BSE are available, furthermore press releases, statements and statistics.
